Old Business

Grants:

- 1. **VSMP with VBCD**: May 1st event was well attended and several sites were sampled.
- 2. **Stream Crossing Inventory with VBRC**: Additional training session was held May 11th with Racheal Wise, MDNR.



- 3. **PPR/Ox Creek with SWMLC and SWMPC:** Community Pint Night fundraiser was at The Livery on May 5, 2016. Paddle event on the Ox Creek was held before Pint Night, 14 paddlers attended. Over 90 pints were sold during event raising \$150 from The Livery and \$523.06 in donations from the event. The Board held discussion on possible future "pint night" fundraisers. TBD
- 4. **CISMA with VBCD**: Erin Fuller, VBCD will be the program coordinator for the grant program for phragmites education and control.
- 5. **Pine Creek Grant/VBC, Colleen Forestieri**: Grant was improved and will include septic system inspection and assistance, work on Van Buren County point of sale, POS ordinance, farmer assistance for reducing E. coli.

Cardno Nursery Field Trip, Walkerton, IN, July 15th (22nd rain date): TRC be hosting a day long field trip to the Cardno Native Plant Nursery in Walkerton, Indiana.
