Transition Team Meeting

## **General Discussion:**

Matt Meersman reviewed pre-meeting topics: Education and outreach were priorities, community leaders and getting the message out were important priorities, and one group with a professional partner being the preferred outlook.

Erin Fuller reviewed tally vote questions and break-out groups-reference hand out

Matt Meersman: Focus on topics/issues that will benefit both watersheds.

Dave Foerster and Frank, Paw Paw Lake discussed the phosphorus ban in relation to both watersheds.

- a. zero phosphorus and slow release nitrogen
- b. guidlines: guards on fertilizer spreaders
- c. Educational ordinance
- d. Erin Fuller-have people from transition team attend local meetings and identify themselves as a group that supports ban.
- e. phosphorus ban is for residential not agriculture. Ag is regulated by MDA
- f. Paw Paw Lake Foundation backed a township resolution and coupons in stores for phosphorus free fertilizers.
- g. recommended that group attend county and local meetings

Topic #3: On going projects and accomplishments

Marcy Cloclough discussed Paw Paw Plan update: 98% done and submitted final to CMI, MDEQ for approval for grants/implementation. Educational plans for implementation could incorporate Black and Paw Paw Rivers.

Erin Fuller on Black River update: The Black River Plan is already in implementation stage and have done education and outreach projects. Finished one project in City of Bangor, bio-swales filtering stormwater, bank revetments, etc... Currently working on project in Village of Bloomingdale installing rain garden and doing river restoration project.

There was discussion from Kalamazoo County Conservation district concerning septic inspections at point of sale as a good option to work toward. You can get a property assessment for your septic: example, Lake Assist and it is confidential. Point of sale septic inspections Affects both watersheds. Deb, Great Bear Lake Association has a voluntary inspection program with dye testing,

Topic #4: Mission Statement

Dave Foerster recommended that the mission statement focus on preservation and/or restoration in both watersheds

Topic #5: Planning Stage-Framework for success

It was recommended that we create a directory of groups and associations in both watersheds. Matt recommended establishing by-laws, membership, future meetings and dates. Then set tasks or goals that the group can accomplish, give direction.
